General Briefing:

FOR SATURDAY: There will be a general briefing at 8:45 am followed by an in-person walkthrough. Judging will begin promptly at 9:00 am. **Please do not arrive before 8:15 am, but everyone MUST arrive prior to the briefing.** Once the trial starts there will be line of sight issues. The running order for Saturday is posted on page 3 of this judging schedule. The running orders for trial 1 and trial 2 are different – please make note of this.

Saturday Parking: Due to line of sight issues, all exhibitors will have to park on the far West side of the parking lot for the AM searches. An attendant will show you where to park. For the afternoon searches, you will be directed to the East Side of the parking lot, again due to line of sight issues.

FOR SUNDAY: We will run in pods of 5 dogs. **Please do not arrive before your pod's scheduled arrival time. First Pod to arrive at 8:30 am.** Each pod will run all dogs in Trial 1 then all dogs in Trial 2. The judge will do a briefing and a walk through for each pod. We have scheduled the dogs that have come the farthest run in the first pods to help you get home earlier.

Sunday Parking: Please park on the north (Right) side of the parking lot due to sight lines. You will be able to stay in the same spot all day.

If you cannot make it on the day of the trial, please text the trial secretary at 414-852-2681.

If you have questions or concerns, please approach the Gate Steward and they will contact one of the Trial Committee members to help you.

Wait List: There is no wait list for these trials but Sunday is full. Day of Event entries for Saturday ONLY will be accepted up to a maximum of 25 runs per trial. These entries will need to be made with the Trial Secretary NO LATER THAN 8:40am on the Sunday.

Ribbons: Ribbons will be available as soon as possible for each trial once all dogs have run. **If you might get your scent detective title at this trial,** please let us know so we can have your special award ready.

Saturday: after each trial, the results will be posted and Qualifying, Placement, and Title ribbons will be hand delivered to the recipients once the scores have been verified. Please give the trial secretary time to do the entering of scores, computing placements and assembling the ribbons – Trial 1 will not have any scores entered until the trial is completed because we are searching the secretary room.

Sunday: if you qualify, and if you earn your SWD title, you will receive your ribbons immediately after your run. If you place in the trial and you want your ribbons, we will get/send the placement ribbons to you. Please give the trial secretary a few minutes to do the entering of scores, computing placements and assembling the ribbons. You may also pick up your ribbons from Saturday on Sunday. Results will be emailed to all exhibitors on Sunday evening.

Site Information: There will be two separate search areas each of the two days. **Saturday's site has an active fire department.** If they are called out while we are there, there will likely be sirens and other loud noises.

Saturday: searches will be outside on grass & concrete and inside on tile/vinyl floors with no carpeting. On Saturday morning after the demo dog runs and before 8:55am, the inside bathrooms can be used. After Trial 1 begins, the only available restroom will be a PortaPotty which is located next to the tennis court. **PLAN ACCORDINGLY!!** On Saturday afternoon, you may enter the front of the building and use those restrooms.

Sunday: searches will be outside on concrete & gravel, and indoors on tile & carpeting. Restroom access will be posted and announced.

At the end of each search, the exhibitor will receive a map of the search areas marked with the hide placements.

Please do not share with competitors yet to run.

Exhibitors are expected to keep the grounds clean. Please clean up after your dogs. **Anyone witnessed not picking up after his/her dog will be excused from the trial with no monies refunded.** Please note that the dog exercise areas will be adjacent to the parking areas.

All crating is to be done in your vehicles. Dogs must be crated or secured in the cars. No ex-pens.

No food for exhibitors will be available on the grounds. It is suggested that you bring your own lunch and beverages. Food & beverages will be available for volunteers.

Warm Up: Warm up/Recovery boxes will be available for each search. Exhibitors should limit their warm-up to one minute or less. The warm-up area is to be used exclusively for warming up the handler-dog team prior to their run, or for recovery after the run. The warm-up area is not for training or relieving of the dog.

Possession of Odors and Training: Chapter 5. Section 26 of the Scent Work Regulations state "No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area."
